- (e) if not, the action taken by the Government in this regard?

(a): The details of targets and achievements made from various renewable energy sources during the last three years and current year are as follows:

(b): Generally implementation of various renewable energy programmes is satisfactory. However, some of the hurdles faced in the implementation of these programmes in states, *interalia*, include servicing and maintenance of renewable energy systems in remote areas; delay in submission of Utilization Certificates of grants released earlier; non-compliance of Renewable Purchase Obligations (RPO); and non-revision of tariffs regularly as per CERC guidelines, etc.
