(b) the details of the average expenditure per passenger incurred on food and allied services provided by Air India;

(c) whether several complaints have been received by Air India regarding poor quality of its in-flight meals during the last three years and the current year and if so, the details thereof along with the action taken by Air India thereon;

(d) whether there has been a recent incident wherein a lizard was found in Air India's in-flight meals and if so, the details thereof along with the action taken in this regard; and

(e) the measures taken by Air India to improve the quality of its in-flight meals?

(a): The details of the caterers who provide catering service to Air India is Annexed. Samples of in-flight meals are checked by the shift Duty Managers on day to day basis. Also, surprise meal checks are carried out at caterer's premises to monitor uplift of meals with regard to quality, quantity, taste, presentation and eye appeal. Discrepancies are brought to notice of the concerned caterer and corrective action taken.

(b) : Average expenditure incurred per passenger on food & allied services is as under :

(c) : The details of complaints received regarding the quality of food served on Air India flights in the last three years and current year is as follows:

(d) : The incident was reported on flight No. AI-111 on Delhi/London sector on 11th June 2015. On investigation, it was found to be a false complaint. It was found that no passenger on the flight had lodged any complaint with the cabin crew on board. The Station Manager also informed that no complaint had been received. Air India has already responded to the media in this regard.

(e) : Air India uplifts in-flight meals from reputed caterers who also cater to other international and domestic airlines. Surprise meal checks are carried out at caterer's premises to monitor uplift of meals with regard to quality, quantity, taste, presentation and eye appeal. Periodic Hygiene Audits are also being carried out at caterer's premises to improve the quality of meals.
