- (a) whether the Union Government has changed or proposes to change the funding pattern under the National Land Records Modernisation Programme;
- (b) if so, the details thereof along with the reasons therefor and the allocation made by the Government under the Programme during each of the last three years and the current year, State/UT-wise;
- (c) whether the Union Government has received representations from State Governments to enhance the funding under this Programme; and
- (d) if so, the details thereof and the actions taken by the Union Government in this regard?

ANSWER

MINISTER OF STATE FOR RURAL DEVELOPMENT (SHRI SUDARSHAN BHAGAT)

(a) & (b): Department of Expenditure, Ministry of Finance, Government of India has conveyed that funding pattern of National Land Records Modernisation Programme (NLRMP) is to be changed to 50:50 [Centre:States]. Details of fund allocated to the States/UTs under the programme during the last three years and current year are given in the annexure.

(c):None of State Governments has represented the Government (in the Ministry of Rural Development) in the context of 50:50 [Centre:States] sharing pattern.
