#### LOSS DUE TO NATURAL CALAMITIES

#### 2854. SHRI FEROZE VARUN GANDHI:

Will the Minister of SHIPPING be pleased to state:

#### पोत परिवहन मंत्री

- (a) the details of losses incurred by the shipping sector due to cyclones and other natural calamities during each of the last three years and the current year;
- (b) the role played by the National Disaster Management Authority (NDMA) in reducing the said losses; and
- (c) the extent to which the Indian Coast Guard has been supported to carry out better search and rescue operations in such natural calamities?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF SHIPPING (SHRI PON. RADHAKRISHNAN)

- (a) The loss incurred by the shipping sector due to cyclone in last three years is enclosed as **Annexure.**
- (b) National Disaster Management Authority (NDMA) has formulated National Guidelines for the Management of Cyclones. These guidelines call for a participatory approach involving all stakeholder groups to strengthen the national vision of moving towards a more proactive pre-disaster preparedness and mitigation-centric approach. The said guidelines contain all the details that help in the preparation of plans by the Central Ministries/Departments and the States/UTs.
- (c) All government agencies concerned whether Central, State or Union Territory, coordinate and support each other during maritime crisis and natural calamities that impact merchant shipping sector. During such crisis, ports provide following facilities/assistance to the Indian Coast Guard for timely conduct of relief operations:
  - (i) Priority berthing facilities for Coast Guard Ships entering ports
  - (ii) Expeditious support in terms of Tugs and support vessels for movement of vessels in/out harbor.
  - (iii) Logistical support towards availability of mooring party and fresh water for Coast Guard ships.
