Vacancies in PSUs

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) whether a large number of Public Sector Undertakings (PSUs) are functioning without Heads/CMD/Chairman at present, if so, the details thereof, PSU-wise;
- (b) the time by which the said appointments are likely to be made;
- (c) whether it is true that Chairman/CMD/Directors of Schedule "C" PSUs companies are getting pay scales of Schedule "B" PSUs, if so, the details thereof and the reasons therefor:
- (d) whether the upgradation of pay scale has been ratified by the appointment Committee of the Cabinet; and
- (e) if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI G.M. SIDDESHWARA)

- (a): As per available information, there are 24 Central Public Sector Enterprises (CPSEs) which presently do not have regular Managing Director (MD)/Chairman & Managing Director (CMD)/Chairman. The list of these 24 CPSEs is annexed.
- (b): The filling up of Board level posts in CPSEs is a continuous process and these 24 vacant posts would get filled on regular basis after completion of all formalities in this regard.
- (c) to (e): The Government has laid down the guidelines for upgradation of Board level posts of CPSE on personal basis which provides for grant of higher schedule of pay to the concerned Board level incumbent. As per available information, CMD, Hindustan Insecticides Limited, a Schedule 'C' CPSE, has been granted pay scale of CMD of Schedule 'B' CPSE under these guidelines. There are no cases approved by Appointments Committee of the Cabinet where Chairman/CMD/Directors of Schedule 'C' CPSEs are getting pay scales of Schedule 'B' CPSEs.
