(a) & (b): Yes, Madam. The Government of India regularly reviews the performance of Central Warehousing Corporation (CWC) through review meetings held in the Ministry. The performance of the Corporation is also reviewed by the Government on the various Static/Financial Parameters and the Dynamic Parameters for which targets are fixed at the beginning of every year through Memorandum of Understanding (MOU) and the Corporation is getting excellent rating regularly on evaluation of its performance.
