### PENDING PROPOSALS UNDER RURAL SCHEMES

### 3934. SHRI LAXMI NARAYAN YADAV:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number of proposals pending with regard to the rural development in Madhya Pradesh as on date;
- (b) the date on which the Government has received the proposals and the proposal-wise reasons for their pendency; and
- (c) the details of action taken by the Government to approve these proposals?

# ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI SUDARSHAN BHAGAT)

(a) to (c): Proposal for release of funds under Mahatma Gandhi National Rural Employment Guarantee Act has been received from the government of Madhya Pradesh for the financial year 2015-16 and is under examination in the Ministry. The details of pending proposals under National Rural Livelihoods Mission are given in **Annexure-I**. Under Indira AwaasYojana, proposal for release of second installment for normal and special projects are pending due to non-availability of sufficient funds during 2014-15. The proposal will be considered during the current financial year depending on availability of funds. During 2014-15, under PradhanMantri Gram SadakYojana the state government had submitted proposals without considering the annual allocation and execution capacity. Hence, the proposal has been returned back to the state government indicating that the eligible proposals can be considered only after additional funds are made available. Under DeenDayalUpadhyayaGrameenKaushalyaYojana nine proposals are pending and the details are given in **Annexure-II**.
