+655. SHRI SHARAD TRIPATHI:

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Government has fixed renewable energy purchase targets for the State Governments;
- (b) if so, the States which have started purchase of renewable energy; and
- (c) the quantity purchased by them during each of the last three years and the current year?

**(a),(b)&(c):** Under the provisions of Section 86(1)(e) of the Electricity Act, 2003 the respective State Electricity Regulatory Commission (SERC) fixes the targets for purchase of renewable energy in the area of distribution licensee in the State. SERCs of all States and UTs except Sikkim have fixed the renewable purchase targets. The State-wise year-wise details of renewable purchase targets for last three year is given at annexure-I.

All states and UTs have started purchase of renewable energy. The renewable energy purchased by the obligated entities was 47.61 Billion Units (BUs) in 2012-13, 53.05 BUs in 2013-14 and 61.78 BUs in 2014-15.
