(a) whether the prices of petroleum products such as petrol and diesel have been deregulated and if so, the details thereof;

(b) whether the State Authorities are charging a major portion as taxes on retail sale prices of petrol and diesel across the country;

(c) if so, the details thereof and the reasons therefor; and

(d) the corrective action being taken/proposed to be taken by Union/State Governments in this regard?

(a) to (d): A statement is laid on the Table of the House.

<u>Statement referred to in reply to parts (a) to (d) of the Lok Sabha Starred Question No.101</u> asked by Shri Godse Hemant Tukaram to be answered on 7th December, 2015 regarding "Prices of Petroleum Products".

(a): The prices of Petrol and Diesel have been made market determined with effect from 26th June, 2010 and 19th October, 2014 respectively. Since then, the Public Sector Oil Marketing Companies (OMCs) take appropriate decision on price of these products in line with changes in the prices in international market and other market conditions.

(b) & (c): Sales Tax/VAT on Petrol and Diesel are being levied by the State Governments on Petrol and Diesel and vary from State to State. The details of effective rate of sales tax/VAT levied by States/UTs as on 01.12 2015 is at **Annexure.**

The details of Central and State taxes included in the Retail Selling Price (RSP) of Petrol and Diesel effective 1.12.2015, at Delhi, as per IOCL is given below:
