Kolar, Karnataka	The project of setting up of Rail Coach Factory at Kolar has been sanctioned with 50% cost sharing by State Government. Government land has been identified. The State Government is yet to hand over the land and contribution of their share of project cost to Ministry of Railways.	Rs.10 cr	Nil
Kanchrapara, West Bengal	Rail Coach Factory/Kanchrapara is planned for manufacturing Electric Multiple Unit (EMU)/Mainline Electric Multiple Unit (MEMU) coaches. The works relating to site development, road connectivity, street lights and 33 KV transmission line, have already been started. Request for Qualification (RFQ) issued in 2010, was annulled and fresh RFQ applications have been invited.	Rs.12.3 Cr.	Rs.13.2 Cr.
