**‘Vacancies in Banks’**

**Question**

\*284: SHRI P. KARUNAKARAN

Will the Minister of FINANCE be pleased to state:

- (a) whether a large number of posts are lying vacant in Public Sector Banks (PSBs) at present if so, the details thereof during the last three years and the current year;
- (b) whether the banks are following RBI guidelines in the filling up of vacancies, if so, the details thereof along with the number of appointments made during the aforesaid period;
- (c) whether the shortage of staff has adversely affected the functioning of these banks especially in rural areas and if so, the details thereof; and
- (d) the measures taken by the Government to fillup such vacant posts expeditiously?

(a) to (d): The details of vacancies and recruitment in Public Sector Banks for three years including current year are annexed.

Public Sector Banks (PSBs) have managerial autonomy in terms of human resource policies and procedures including recruitment. PSBs undertake recruitment of staff to fill vacancies on ongoing basis as per their requirements depending upon business volume, business growth, employee strength and retirements etc. Reserve Bank of India (RBI) has not issued any guidelines regarding recruitment in PSBs. Government has advised PSBs to have a succession plan in order to handle shortage of staff in their Banks.
