Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) whether a number of directorial posts are lying vacant in various PSUs at present thereby affecting efficiency, if so, the details thereof and the time since when such posts have remained vacant;
- (b) whether the Government has taken steps to fill up these vacancies; and
- (c) if so, the details thereof and the time by which the said vacancies are likely to be filled?

## Statement referred to in reply to Lok Sabha Starred Question No. 29\* for answer on 1.12.2015 regarding Vacant Posts in PSUs

- (a): The Boards of Central Public Sector Enterprises (CPSEs) consists of (i) functional (full-time), (ii) government (part-time) and (iii) non-official (part-time) Directors. As per available information, 77 posts of functional Directors and around 470 positions of non-official Directors are presently vacant. The details of 77 vacant posts of functional Directors in CPSEs are annexed.
- (b) and (c): Out of the 77 vacant posts of functional Directors in CPSEs, the recommendations of Public Enterprises Selection Board (PESB)/Search-cum-Selection Committee are already available in respect of 38 posts and PESB/concerned administrative Ministry have initiated the selection process in respect of 31 other posts. The competent authority has approved the proposal for appointment in respect of 7 posts and 1 post is vacant due to Court case.

In respect of vacant posts of non-official Directors, Search Committee has recently recommended names for filling up 156 positions on the Boards of various CPSEs of which 92 non-official Directors have already been appointed. The filling up of Board level posts in CPSEs is a continuous process and the vacant posts get filled after completion of all formalities.
