# Statement in answer to parts (a) to (d) of the Lok Sabha Starred Question No. 340 for 22.12.2015 by Shri Arjun Meghwal regarding income Limit under PMS.

(a) Post-matric Scholarship Scheme for Scheduled Castes Students is a centrally sponsored scheme and is implemented by the States/UTs administration since 1944.

(b) The annual income limit of the parents/guardians under the scheme was increased from Rs. 2.00 lakh to Rs. 2.5 lakh w.e.f. Academic session 2013-14. At present there is no proposal to increase the annual income limit of the parents/guardians under the scheme.

(c) & (d) Central Assistance to the States/UTs is released after examining their proposal, utilization certificate of fund released for the previous year and based on the availability of fund under the scheme. A statement giving the details of the demand made including arrears for past, Central Assistance released, balance due as on date is at annexure. Central Assistance including balance to States/UTs is given on receipt of complete proposal subject to availability of funds.
