## \*58. SHRI DHANANJAY MAHADIK: DR. HEENA VIJAYKUMAR GAVIT:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) the total number of Industrial Training Institutes (ITIs) in the country with the details of these Institutes run by the Government and private sectors respectively, Statewise;

(b) whether there is unprecedented interest in setting up of new ITIs during the past five months;

(c) if so, the details of new ITIs set up and the reasons for renewed interest, along with the States that have established largest number of ITIs;

(d) whether the Government proposes to monitor the quality and performance of these ITIs keeping in view the students' career, if so, the details thereof; and

(e) whether the Government is considering utilization of capacities in Engineering Institutes by introducing skill development and entrepreneurial courses and if so, the details thereof and the steps taken by the Government in this regard along with the response received thereon?

# ANSWER MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

(a) to e) A statement is laid on the table of the House.

## STATEMENT REFERRED TO IN REPLY TO PART (a to e) OF LOK SABHA STARRED QUESTION NO. \*58 RAISED BY HON'BLE M.P SHRI DHANANJAY MAHADIK AND DR. HEENA VIJAYKUMAR GAVIT, REGARDING INDUSTRIAL TRAINING INSTITUTES DUE FOR REPLY ON 02.12.2015.

(a) At present, total number of Industrial Training Institutes (ITIs) in the country is 13,105 (Govt. 2293 & Private 10,812) with total seating capacity of 18.65 lakh (Govt. 5.05 & Private 13.60 lakh). State wise details of ITIs is at **Annex-I.** 

(b) & (c) Setting up of new ITIs and addition of trade/units in existing ITIs is a regular process. State-wise details of new 999 ITIs (largest 309 in Madhya Pradesh) granted affiliation to NCVT during last five months is at **Annex-II.** There has been increase in applications for setting of new ITIs. This is due to a number of factors including increasing demand for skilled manpower.

(d) Quality Council of India (QCI) - non-profit society has been engaged w.e.f. 01.09.2012 for accreditation / inspection of ITIs to ensure availability of infrastructure facilities as per the norms laid down by the National Council for Vocational Training (NCVT) with online system on its web portal. There is a provision of annual surveillance of ITIs as a part of accreditation to monitor the quality and performance of ITIs. In addition, State Governments have also been allowed to conduct inspections as per their schedule. Further a system of Grading of ITIs through a crowd based I.T platform has also been initiated by the Ministry to monitor quality of ITIs in the country.

(e) Running Skill training Courses compliant to National Skill Qualification Framework in spare capacity of Polytechnics and Engineering colleges for optimal utilization of available infrastructure has been taken up with All India Council for Technical Education (AICTE) by this Ministry.
