(a) : State-wise details of funds allocated and releases made under various plan schemes are provided in the Annex-I and Annex-II respectively.

(b) to (d): The releases towards Central assistance to the States depend on several factors such as scheme guidelines, finalization of schemes by the States, availability of resources, absorption capacity and on receipt of certificates from the State Governments that grants has been utilized for which it was sanctioned, balance that remain unutilized is adjusted towards the grants-in-aid payable during the next year.
