(c) the role at present assigned to women pilots serving in the IAF;

(d) whether women pilots are undergoing specialised training including survival techniques to face any critical situation in combat zones and if so, the details thereof; and

(e) the time by which the first batch of women fighter pilots are likely to be inducted into the IAF?

## **STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (e) OF LOK SABHA UNSTARRED QUESTION NO. 1014 FOR ANSWER ON 4.12.2015**

(a): The number of women officers recruited in the Defence forces during the last three years and the current year, service-wise is as under:

Year	Army	Navy	Air Force
2012	157	32	130
2013	127	42	144
2014	104	58	155
2015 (till date)	72	39	68

(b): Government has accorded the approval to entry of women into the fighter stream of IAF on experimental basis for a period of five years.

(c): All women pilots in IAF are cleared for all operational roles including Low Level Tactical Flying, Para Drop, Air Maintenance (Northern & Eastern Sector) and Special Heli-Borne Operation (SHBO).

(d): Women pilots undergo Jungle & Snow Survival Course.

(e): It is envisaged that the women trainees undergoing Stage-I training at Air Force Academy would be assessed for their suitability. Based on the suitability and willingness, these women trainees would be selected for Stage-II training in the fighter stream. Upon successful completion of Stage-II training, these women trainees are likely to be commissioned into the fighter stream in June, 2016.
