AGE NORMS FOR OFFSHORE LOGISTIC SUPPORT VESSELS

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) Whether the Oil and Natural Gas Corporation Limited has introduced new guidelines or issued directives/suggestion to introduce age norms for charter hiring of Offshore Logistic Support Vehicles and if so, the details thereof;

(b) The details of Indian vessels rendered out of service after the introduction of said age norms;

(c) Whether the number of foreign flagged vessels being chartered for Offshore Logistic Support has increased after introduction of the said norm; and

(d) if so, the details thereof?

- (a) Oil and Natural Gas Corporation Limited introduced age norms for charter hire of Offshore Logistics Support Vessels in 2012 in stages as shown below:-
- 1. The upper age limit of 27 years for the tenders to be published in 2012-13.
- 2. The upper age limit of 24 years for the tenders to be published in 2013-14.
- 3. The upper age limit of 21 years for the tenders to be published in 2014-15.

The upper age limit of 21 years is being maintained from 15-16 onwards.

(b) The details of Indian vessels rendered out of service after the introduction of said age norms are as under:-

(c) & (d)- After introduction of age norms, 4 Nos. of foreign flag vessels were inducted in total fleet of 74 vessels. However, the Right of First Refusal is given for Indian Flag Vessels. In case, Indian Flag vessels do not match the lowest rates, then these rates are offered to foreign flag vessels.
