- (a): Coconut Development Board has been implementing various schemes/programmes to enhance coconut production in the country as given under:
 - 1. Production and distribution of planting material
 - 2. Expansion of Area under Coconut
 - 3. Integrated Farming for Productivity Improvement
 - 4. Replanting and Rejuvenation of Coconut Gardens
 - 5. Establishment of new coconut orchards
 - 6. Coconut Palm Insurance Scheme (CPIS)
 - 7. Technology Demonstration/Quality Testing Lab, etc.
- (b): Coconut Development Board introduced the Technology Mission on Coconut in the year 2001-2002 with the main objective of promoting product diversification and value addition in coconut. Details of the scheme are given at Annexure-I

Technology Mission on Coconut covers four major components as given below:-

In addition to above, the Board is also implementing the following programmes to promote processing and value addition of coconut in the country:

(i) Technology Demonstration/Quality testing lab

The Technology Development Centre is operating at Vazhakulam, Aluva, Kerala. A full fledged Quality Testing Laboratory (QTL) is operating at the Technology Development Centre, Vazhakulam.

(ii) Export Promotion Council

The Department of Commerce, Ministry of Commerce and Industry, Government of India has notified Coconut Development Board as an Export Promotion Council (EPC) for all coconut products other than those made from coconut husk and fiber.
