- (c) whether any proposals have been received by the Government from various quarters to include more cities under industrial corridors and if so, the details thereof along with the action taken thereon and the time-frame fixed for completion of industrial corridor projects; and
- (d) the status of constitution of National Industrial Corridor Development Authority announced by the Government?

(a): The Government is working on implementation of Delhi Mumbai Industrial Corridor (DMIC), Vizag –Chennai Industrial Corridor (VCIC), Chennai-Bengaluru Industrial Corridor (CBIC), Bengaluru-Mumbai Economic Corridor (BMEC) and Amritsar Kolkata Industrial Corridor (AKIC). Out of these VCIC & CBIC are being implemented with the assistance of Asian Development Bank (ADB) and Japan International Cooperation Agency (JICA) respectively.
