178. SHRI MOHITE PATIL VIJAYSINH SHANKARRAO:

Will the Minister of **MINES** be pleased to state:

- (a) the quantum of copper wire imported from ASEAN countries during each of the last three years and the current year;
- (b) the quantum of copper export along with the foreign exchange earned therefrom during the said period, country-wise;
- (c) whether the copper import is more than export of copper products and if so, the details thereof and the reasons therefor;
- (d) whether major copper companies have cautioned the Government that the sector is facing an imminent shutdown in the face of a surge in cheaper copper imports from Japan and ASEAN countries; and
- (e) if so, the details thereof along with the corrective steps taken by the Government in this regard?

ANSWER

THE MINISTER OF STATE FOR MINES AND STEEL (SHRI VISHNU DEO SAI)

(a) The quantum of copper wire imported from ASEAN countries during each of the last three years and current year is given below:

(b) There is no export of copper concentrate in the current year. However, the quantum of export of refined copper and foreign exchange earned therefrom during the last three years and current year is given below:

- (c) No Madam, with regards to refined copper, import is not more than export.
- (d)&(e) Indian Primary Copper Producers Association has informed the Ministry that there is surge in import of refined copper from ASEAN and Japan under the Fee Trade Agreements (FTA). The Association has therefore requested that the import duty on finished copper be enhanced. The Ministry has examined the matter, and as of now, there is not enough ground for intervention. However, the Ministry is keeping a close watch on the matter.
