FUNDS UNDER RAY

No. 1835 SHRI NANDI YELLAIAH:

Will the Minister of HOUSING AND URBAN POVERTY ALLEVIATION be pleased to state:

- (a) whether Andhra Pradesh Government has recently sent a proposal for Rs. 5000 crores to the Central Government for 'Rajiv Awas Yojana" for construction of pucca houses for the poor in slum areas of the State;
- (b) the details of various slum areas to be covered under the said project, with locations, district- wise;
- (c) the number of houses constructed and completed for occupation so far, under this project in Andhra Pradesh and Telangana State, District-Wise locations thereof;
- (d) the number of houses still remain to be constructed under the said project in Andhra Pradesh and Telangana State; district-wise and location-wise;
- (e) the maximum period involved in completing this project for Andhra Pradesh and Telangana State; and
- (f) the details of frauds detected so far and necessary action taken sofar, against the offenders?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING & URBAN POVERTY ALLEVIATION
(SHRI BABUL SUPRIYO)

(a) to (d): No, Madam. No such proposal for construction of pucca houses under Rajiv Awas Yojana (RAY) for the poor in slum areas of the State of Andhra Pradesh has been received recently. Under RAY, a total of 3 projects were earlier approved with a total project cost of Rs. 145.94 crore involving a central share of Rs. 63.51 crore for construction of 2815 houses in Andhra Pradesh and Telangana. These projects have since been subsumed in new mission Pradhan Mantri Awas Yojana – Housing for All (Urban).

District-wise and location-wise details of RAY projects in Andhra Pradesh and Telangana including the slums covered are at Annexure.

(e): Completion of construction of these projects depends on the State Government as Urban Local Bodies (ULBs) / Implementing Agencies of the State Government concerned are executing these projects as per the approved project plan. In general, time taken for completion of project under RAY is 12-24 months.

(f): Ministry has not received any complaint of fraud in implementation of RAY in Andhra Pradesh and Telangana.
