Research Work in Coal Sector

1870. SHRIRABINDRA KUMAR JENA:

Will the **MINISTER OF COAL** be pleased to state:

- (a) whether any research work is being carried out in government institutes to enhance the quality and production of coal in the country;
- (b) if so, the details thereof along with the progress achieved including the number of personnel engaged in research/administration/services in these institutes;
- (c) whether the amount of investment on research and development in coal sector is adequate;
- (d) if so, the amount spent by the Government on these institutes during each of the last three years and the current year; and
- (e) whether the Government plans to enhance investment in research and development in the coal sector and if so, the details thereof?

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF COAL, POWER AND NEW AND RENEWABLE ENERGY (SHRI PIYUSH GOYAL)

(a)& (b): The Government of India through its Coal Science & Technology (S&T) scheme and Coal India Limited (CIL) through its Research & Development (R&D) scheme undertake R&D activities for improvement in production, productivity and safety in coal mines, coal beneficiation and utilization, protection of environment and ecology and other related activities. R&D activities are administered through Standing Scientific Research Committee (SSRC headed by Secretary (Coal) and R&D Board of CIL headed by Chairman, CIL

Since introduction of research funding of Ministry of Coal [MoC] and Coal India Limited, a large number of research projects have been carried out by various academic and research institutes related to the coal and allied industries with active participation of coal and lignite mining companies. Many of these projects have yielded considerable benefits, resulting in operational improvement, safer working conditions, better resource recovery and protection of the achievement.

At present, there are 34 on-going research projects with total outlay of more than Rs. 200 Cr at various academic and research institutions in association with coal and lignite producing companies.

Under the above R&D scheme, different Government academic/research institutions are involved in the researchwork in coal sector. A fewof the Government academic/research

institutions which have undertaken the research work for the last three years are given below:

In Research projects, havebeen staff component which generally includes Project Coordinator, Project Leader and a few Senior Research Fellows / Junior Research Fellows / Research Associates are engaged by the concerned implementing agency to facilitate the research work.

- (c): Adequate funds are earmarked annually by the Ministry of Coal (MoC) and Coal India Limited (CIL) to carry out research work in coal and lignite sector for the areas mentioned above.
