- (e) During last three years, following Two 787-8 Dreamliner aircraft were on ground.
- 1. VT-ANI from 23-4-2014 to 14-02-2015. 2. VT-AND from 02-01-2015 to 27-11-2015.

The key reason for prolonged grounding was non availability of Spares and Components/ Line Replaceable Units. Presently, all Dreamliner aircraft are in airworthy condition.

(f) All possible efforts have been made to ensure On Time Performance (OTP) of AI flights. The OTP is being monitored at the highest level within Air India on daily basis. A video conference is anchored by Integrated Operation Control Centre (IOCC) everyday in which the representatives of operating departments from four regions participate to review the previous day's operation and evolve process improvement wherever possible. Wherever required, issues are taken up with Airport operators, ground handling agencies etc. The Ministry also regularly monitors the OTP of AI.
