- (a) the details of welfare schemes being implemented for the handloom weavers in the country along with the funds allocated, released and spent thereon during each of the last three years and the current year, State-wise;
- (b) the achievement made in providing the marketing facilities to weavers and the number of weavers benefited under the said schemes during the said period, State-wise;
- (c) whether the handloom weavers and their family members are committing suicides due to financial crisis;
- (d) if so, the details and reasons therefor including the number of weavers committed suicides during the said period, State-wise along with the steps taken by the Government for the upliftment of handloom weavers; and
- (e) the details of provisions made by the Government to set up handloom parks for the development of handloom weavers and the amount allocated for the purpose along with the new handloom parks likely to be opened in the country, State-wise?

ANSWER

- (a) For holistic and sustainable development of handloom sector and welfare of handloom weavers, following schemes are under implementation during 12th Plan:
 - (i) National Handloom Development Programme two components
 - Revival, Reform & Restructuring (RRR) Package for handloom sector
 - Comprehensive Handloom Development Scheme (CHDS)
 - (ii) Handloom Weavers' Comprehensive Welfare Scheme two components
 - Health Insurance Scheme (HIS)
 - Mahatma Gandhi Bunkar Bima Yojana (MGBBY)
 - (iii) Yarn Supply Scheme
 - (iv) Comprehensive Handloom Cluster Development Scheme (Development of Mega Handloom Cluster)

The details of the above mentioned schemes are given in $\underline{\mathbf{Annexure}} - \underline{\mathbf{A}}$

The State-wise fund allocated/released/spent in the last three years and current year are given in $\underline{\mathbf{Annexure}} - \underline{\mathbf{B}}$. In some schemes, funds have been released to all over India basis, the state-wise fund not released. The details of funds allocated/released/spent during last three years and current year is given in $\underline{\mathbf{Annexure}} - \underline{\mathbf{C}}$.

- (b) Details of marketing event organised and weavers benefitted is in **Annexure D**.
- (c) & (d): No such established case has been reported by states.
- (e): At present there is no provision for setting of handloom parks. Block level cluster development projects are being supported by Government of India.

Details of welfare Schemes under implementation for handloom weavers

(i) National Handloom Development Programme with the components of-

- (a) Revival, Reform & Restructuring (RRR) Package for handloom sector Package covers waivers of overdue loan 100% principal and 25% of interest as on 31.3.2010 and recapitalization assistance of eligible apex and primary weavers of the cooperative societies & individual weavers and also provides fresh loan at 6% interest rate alongwith credit guarantee for 3 years. The RRR package was approved for implementation upto 28.2.14. For providing access to subsidized term loan as well as working capital loan to handloom weavers not covered under loan waiver package, government has approved concessional credit component. The loan is sanctioned to weavers at 6% interest and Government of India interest subvention is maximum 7% and to leverage the loan, government provides margin money assistance upto Rs.10,000 per weaver and credit guarantee through Credit Guarantee Trust Fund for Micro and Small Enterprises (CGTMSE).
- (b) <u>Comprehensive Handloom Development Scheme (CHDS)</u> CHDS has been formulated by merging all the major components of the schemes namely Integrated Handloom Development Scheme (IHDS), Marketing and Export Promotion Scheme (MEPS) Diversified Handloom Development Scheme(DHDS) implemented during the 11th plan and 2012-13 which is one of the components of National Handloom Development Programme (NHDP) for its implementation during 12th Plan.
- (ii) <u>Handloom Weavers Comprehensive Welfare Scheme (HWCWS)</u> –HWCWS has two components namely Health Insurance Scheme (HIS) and Mahatma Gandhi Bunkar Bima Yojana (MGBBY). The HIS which aims at enabling the weavers community to access healthcare facilities has been transferred to Ministry of Health and Family Welfare w.e.f. 01.4.2015. The MGBBY aims to provide insurance cover to handloom weavers in the case of natural as well as accidental death and in cases of total and partial disability. A scholarship of Rs.300/- per quarter per child subject to two children studying in standard IX to XII is also provided under the scheme.
- (iii) <u>Yarn Supply Scheme</u> This scheme makes available all types of yarn at Mill Gate Price to the eligible handloom agencies and the transport and depot operating expenses @ 2% are being reimbursed by Government of India. Further, to provide the subsidized yarn to handloom weavers in order to compete with powerloom and mill sector, a new component of 10% price subsidy on cotton hank yarn, domestic silk yarn and woollen yarn is also provided.
- (iv) Comprehensive Handloom Cluster Development Scheme (Development of Mega Handloom Clusters) —The objective is to develop Mega Handloom Clusters that are located in clearly identifiable geographical locations that specialize in specific products, with close linkages and inter dependents amongst the key players in the cluster by improving the infrastructure facilities, with better storage facilities, technology up-gradation in pre-loom/on-loom/post-loom operations, weaving shed, skill upgradation, design inputs, health facilities etc. which would eventually be able to meet the discerning and changing market demands both at domestic and at the international level and raise living standards of the millions of weavers engaged in the handloom industry.
