STERILISATION

2132. SHRI S.P. MUDDAHANUME GOWDA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the share of sterilisation as a birth control method in the country as compared to other countries with similar demographics;
- (b) the incentives offered by the Government to doctors, nurses and health workers involved in the sterilisation process and to the individual undergoing sterilisation;
- (c) the number of deaths reported in the sterilisation procedure in the country during each of the last three years and the current year, State/UT-wise;
- (d) whether the Government distributes first and second generation oral contraceptive pills when fourth and fifth generation pills are more effective; and
- (e) if so, the details thereof along with the reasons therefor and the corrective measures being taken by the Government in this regard?

- (a): The share of sterilization for various countries with similar demographics is placed at Annexure I.
- (b): The government pays compensation to doctors, nurses, health workers on differential basis as per the category of the States as given in Annexure II.
- (c): The States/UT wise details are given in Annexure-III
- (d) & (e): The government's basket of choice includes oral contraceptive pills as recommended by WHO Handbook on Family Planning (2011).
