(a) to (d): Based on the decision taken in the 49th meeting of the Council of IITs held on October 6, 2015 at IIT Bombay, Ministry of Human Resource Development constituted a Committee of six eminent persons under the Chairpersonship of Prof. Ashok Mishra, Chairman, Board of Governor, IIT Roorkee to review the current JEE System for admission in IITs. The Committee has submitted its report on November 5, 2015, which has been circulated to all IITs and also uploaded on the website of the Ministry for feedback/comments of stakeholders.

The Committee has submitted its report on 5.11.2015 which is under examination in the Ministry. The report has been uploaded on MHRD website for discussion with the stakeholders and requested them to send their feedback/comments by 30.11.2015.
