VACANT POST OF AYUSH DOCTORS/ PRACTITIONERS

2241. SHRIMATI JYOTI DHURVE:

Will the Minister of AYURVEDA,YOGA AND NATUROPATHY,UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

(a) whether large number of posts of AYUSH doctors/ practitioners including Homoeopathy and Unani are lying vacant in the country;

(b) if so, the details thereof stream and State/UT-wise; and

(c) the steps being taken to fill these vacancies along with the time by which these vacancies are likely to be filled?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI SHRIPAD YESSO NAIK)

(a) & (b): The details of posts of AYUSH doctors/ practitioners including Homoeopathy and Unani lying vacant in CGHS hospitals/ dispensaries stream and State/UT-wise are at Annex.

(c): The vacant posts are filled by the Government in consultation with the Union Public Service Commission (UPSC), who advertises the posts and conducts the examinations, etc. of the candidates and finally recommends them to this Ministry for appointment as Medical Officer (MO)/ Research Officer (RO). The proposals for filling up the vacant posts of MO/RO in Ayurveda, Homoeopathy & Unani streams have already been sent to the UPSC recently and the proposal for MO(Unani) is likely to be submitted shortly. The timeline to fill up these vacancies cannot be specified. However, the vacancies can be filled up only after the UPSC recommends the candidates and the pre-appointment formalities of the recommended candidates are completed in consultation with the respective State authorities.
