GUIDELINES ON HEALTH DRINKS AND TONIC

- (a) whether the Government has set up any panel to formulate the regulatory guidelines for health drink products, nutrition and other direct medical formulation of health tonic;
- (b) if so, the details and the composition thereof; and
- (c) the details of the said guidelines?

(a) & (b): Section 13 of the Food Safety and Standards Act, 2006, inter alia, provides for establishing Scientific Panels on topics specified in this section. The present composition of the Scientific Panel on Functional Foods, Nutraceuticals, Dietetic Products and other Similar Products is annexed.

(c) : The draft Food Safety and Standards (Food or Health Supplement, Nutraceuticals, Food for Special Dietary uses, Food for Special Medical Purpose, Functional Foods and Novel Food) Regulations, 2015 have been notified in the Gazette of India vide Notification No.1-4/Nutraceutical/FSSAI-2013 dated 30.07.2015.
