Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the details of National Dairy Development Board's initiative for ensuring rural milk producers' greater access to organized milk processing sector, since the inception of the scheme; and
- (b) the number of ongoing projects and the quantum of funds sanctioned so far under the National Dairy Plan (NDP), State/UT-wise?

ANSWER

- (a) The National Dairy Plan Phase 1 (NDP-1), a Central Sector Scheme of Government of India, is a scientifically planned multi-state initiative being implemented by the National Dairy Development Board (NDDB) with the network of End Implementing Agencies (EIAs) for the period 2011-12 to 2018-19 with the following objectives:
 - i. Increase productivity of milch animals and thereby increase milk production to meet the rapidly growing demand for milk.
 - ii. Provide rural milk producers with greater access to the organised milk processing sector.

NDP-1 is being implemented in 18 States which accounts for more than 90 per cent of the country's milk production. However, coverage of NDP I will be across the country in terms of benefits accrued from the project.

(b) Under NDP-1, till date, 342 sub projects from 18 States have been approved with the total approved outlay of Rs. 1866.70 crore. The approved sub projects include 116 sub projects from 17 States under the component Village Based Milk Procurement System which aims at providing rural milk producers with greater access to the organised milk-processing sector by forming and strengthening Dairy Cooperatives and Producer Companies. State-wise approved sub projects under National Dairy Plan (Phase-1) for all the components and the sanctioned fund are as given in Annexure.
