PROCUREMENT BELOW MSP

2701. SHRI CHHEDI PASWAN:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the Union Government and State Government purchase grains below and above Minimum Support Price under specific circumstances through various agencies;
- (b) if so, the details Rice/Paddy purchased under the said conditions during the last three years and the current year, year and State-wise including Bihar;
- (c) whether the Union and State Governments have fixed any time-frame for the purchase of paddy;
- (d) if so, the details thereof along with the reasons if any, for delay in procurement at the centres; and
- (e) whether the Government has made any evaluation of the purchase of paddy from the farmers and if so, the details and the outcome thereof?

A N S W E R MINISTER OF CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI RAM VILAS PASWAN)

(a) & (b): There is a Uniform Policy for procurement by Govt. Agencies across the country. Under this policy, whatever foodgrains are offered by farmers, within the stipulated period and which conform to the specifications prescribed by Government of India are purchased at Minimum Support Price (MSP) by the Government agencies including Food Corporation of India (FCI) for central pool. However, if any producer/farmer gets better price in comparison to MSP he is free to sell his produce in Open market i.e. to private trader/ anyone. Government of India (GOI) declares MSP for each season to incentivize the farmers.

However, in certain circumstances procurement of foodgrains is conducted at a price higher or lower than the minimum support price (MSP). When Govt. (Union/State) declares bonus over and above MSP, foodgrains are procured at higher than MSP. When relaxations in quality specifications with certain value cut are declared, Govt. agencies procure foodgrains at a price lower than MSP imposing value cut accordingly.

No bonus over and above MSP has been declared by GOI during last three years and current year. Bonus given by different States above MSP and quantities of Paddy (in terms of rice) procured is enclosed as Annexure-I.

Further, details of relaxation given in paddy/rice are enclosed as Annexure-II. Data on quantity of paddy procured with value cut is maintained by State.

(c) & (d): Yes, Madam. For every marketing season, the period of procurement and the milling period (for paddy) are decided in respect of the procuring states in consultation with the concerned State Food secretaries keeping in view the crop pattern, estimates of production, available milling capacities etc., in a meeting convened by GOI for review of arrangement to be made for procurement in central pool.

Reasonable time period extensions for procurement and milling are also acceded to by GOI from time to time based on the proposals of state Governments citing justified and acceptable reasons. However, the state Governments is required to get the approval of GOI in advance by furnishing the prescribed information along with their request for extension of milling period.

(e): A study has been conducted by NITI Ayog on evaluation of the efficacy of Minimum Support Price on farmers recently for the reference period of 2007-08 to 2010-11.

Main findings of the study are:-

- (a) The 81% of the cultivators are aware of MSP fixed for different crops in various States.
- (b) It is found that 32.13%, 41.29% and 27.4% of the farmers received their MSP payment in cash, cheque in the shape of bank deposits respectively.
- (c) 67% of the farmers sold their produces through their own arrangements, whereas 21% of them sold through brokers. The share of sales through private and Government Agencies were 8% and 4% respectively.
- (d) It is found that 78% of the farmers adopted improved methods of farming.
- (e) 94% of the farmers wanted MSP to continue.
