### LOK SABHA UNSTARRED QUESTION No. 2820 TO BE ANSWERED ON 16.12.2015

Grants to State Waqf Boards and Minority Women

#### 2820. Dr. A. Sampath:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether the State Waqf Boards could not utilise the grant-in-aid and as a result thereof, there was no spending on a number of schemes including scheme for leadership development of minority women;
- (b) if so, the details thereof during each of the last three years, State-wise including Telangana and the reasons therefor; and
- (c) the steps taken/being taken to ensure that such situation does not arise in future?

# ANSWER MINISTER OF STATE IN THE MINISTRY OF MINORITY AFFAIRS (SHRI MUKHTAR ABBAS NAQVI)

(a) & (b) This Ministry implements two Plan Schemes namely (i) "Computerisation of records of State & UT Waqf Boards" and (ii) Strengthening of State Waqf Boards, in which Grants-in-aid is provided to State / UT Waqf Boards. The Grants-in-aid under the Scheme of Computerisation of records of State & UT Waqf Boards (SWBs) have been provided to State Waqf Boards for setting up of Central Computing Facility & handholding charges. The State Waqf Boards have utilized the funds for the purpose, it was released except the State Waqf Boards mentioned below who are still having unspent fund as per detail given below:

<sup>\*</sup>Since, the scheme for dissolution and reconstitution of the State Waqf Boards for the States of Andhra Pradesh and Telangana has been notified vide notification dated 07.09.2015, no separate fund was released to Telangana State Waqf Board in 2014-15 as the Telangana State Waqf Board was not in existence.

# The funds for the year 2015-16 are yet to be released.

Except above mentioned two schemes, no other schemes of this Ministry are implemented through Waqf Boards. The scheme of "Nai Roshni" for Leadership Development of Minority Women is a Central Sector Scheme implemented directly by the Ministry through selected organizations. The funds released to the selected Non Governmental Organizations, State-wise, for implementation of the Scheme of "Nai Roshni" during last three years and current year is enclosed as Annexure-I.

(c) The Scheme of Computerisation of records of State & UT Waqf Boards is now being implemented through Central Waqf Council. Since State & UT Waqf Boards did not utilize the fund provided to them, the work of data entry of records of Waqf properties and its digitization under the scheme of "Computerisation of records of State & UT Waqf Boards" has been outsourced to National Small Industries Corporation, an undertaking of Ministry of Micro Small & Medium Enterprises by Central Waqf Council since 2013-14. Hence, no Grants-in-aid are being provided to SWBs under this scheme.
