SHRI SUMEDHANAND SARSWATI: SHRIMATI SANTOSH AHLAWAT:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government had launched a new Scheme "Swachhta Udyami Yojana" (SUY) during 2014, if so, the details thereof and the salient features of the scheme;
- (b) whether the Government has received any propsal from various States for financial Assistance under the said scheme;
- (c) if so, the details thereof, State-wise including Rajasthan along with the purpose for which financial assistance has been sought; and
- (d) the action taken by the Government in this regard?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI VIJAY SAMPLA)

(a) Yes Sir, Ministry of Social Justice and Empowerment has launched on the Swachhta Udyami Yojana (SUY) on 02^{nd} October 2014.

The details and salient features of the scheme is enclosed at **Annexure-I**.

- (b) & (c) Yes Sir, various proposals have been received under the scheme for sanction by National Safai Karamcharis Finance and Development Corporation (NSKFDC). The State-wise details with the purpose for which financial assistance is sought, are enclosed at **Annexure-II.** Due to non-receipt of project proposals under SUY from the State of Rajasthan, funds under the scheme of SUY could not be sanctioned and disbursed to Rajasthan State Channelizing Agency.
- (d) The proposals received from the State Channelizing Agencies (SCAs) & Regional Rural Banks (RRBs) under the scheme of Swachhta Udayami Yojana (SUY) have already been sanctioned by the NSKFDC and no proposal is pending for sanction.
