- (d) if so, the number of accidents which took place in Mumbai local trains during the last three years and the number of persons killed in these accidents; and
- (e) the details of safety measures the Government proposes to take in Mumbai local trains on the line of Metro trains to decongest stations?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF UNSTARRED QUESTION NO. 2865 BY SHRI RAHUL SHEWALE, DR. SHRIKANT EKNATH SHINDE, SHRI GOPAL SHETTY AND SHRI VINAYAK BHAURAO RAUT TO BE ANSWERED IN LOK SABHA ON 16.12.2015 REGARDING CROWD IN LOCAL TRAINS

(a) & (b) No, Madam. For the period April-November, 2015 as compared to April-November 2014, Mumbai Suburban Passenger unreserved ticket sales has shown a downward trend, i.e. by 70 millions (approx.). However, the sale of unreserved tickets are not train specific and hence the details of train-specific occupancy/ overcrowding cannot be determined. With a view to increase throughput, moreover, Railways has augmented suburban EMU rakes from 09 cars to 12 cars and also initiated introduction of 15 cars' services.

(c) & (d) No, Madam. However, the number of incidents of falling of persons from running train which took place in Mumbai local trains during the last three years and the number of persons killed in these incidents is as under:

(e) At present, it is not found feasible to decongest suburban stations on the pattern of Metro Railway owing to infrastructural/ resource constraints.
