(a) & (b) The total number of accounts opened under the Sukanya Samriddhi Account Scheme and total amount deposited in the Scheme, Postal Circle wise up to 30.11.2015 are furnished in **Annexure.**

- (c) The following steps have been taken at all level to make the scheme, a success.
 - Wide publicity through print and electronic media, newspapers, radio jingles and TV advertisement by National Savings Institute (NSI) and by the Department of Posts.
 - Organizing Seminars/Melas/Road Shows.
 - Approaching parents through Schools.
 - Using social security payment interface to appeal family members/ grand parent etc.
 - Identifying internal customers (employees) having eligible girl child in family and appealing to them.
 - Linking up with PLI/RPLI/Philately events to spread awareness.
 - Camp at hospital & nursing home to enroll girl child in the scheme immediately after birth.
 - Organizing function at Panchayat, Aganbari Kendras, self help group and other women organizations.
 - Fixing target for each Postal Circle in proportion to population of girl child in the state.
