#### **USAGE OF AGRO-TEXTILES**

be pleased to state:

- (a) whether the Government has implemented the scheme for usage of Agrotextiles in various parts of the country;
- (b) if so, the details thereof including Objectives achieved, State-wise;
- (c) whether any central assistance has been given to various states including Maharashtra for implementation of the said scheme during the last three years and the current year; and
- (d) if so, the details thereof, State-wise?

### उत्तर ANSWER वस्त्र राज्य मंत्री (स्वतंत्र प्रभार) (श्री संतोष कुमार गंगवार) MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF TEXTILES (SHRI SANTOSH KUMAR GANGWAR)

(a) & (b). Yes, Madam. Ministry of Textiles is implementing two schemes for promoting usage of Agrotextiles as under:-

(i) Scheme for Promoting Usage of Agrotextiles in North-Eastern (NE) Region:- It is a five year scheme under the 12<sup>th</sup> five year plan with a total outlay of Rs.55 crore. The objective of the scheme is to encourage utilization of Agrotextiles in improving the agriculture, horticulture, floricultural and sericulture produce of the N-E States. Under the Scheme, demonstration centres depicting the benefit of usage of Agrotextile products are being set up with 100% Govt. support with upper limit of Rs. 20 lakhs per demonstration centre. Training is being imparted to farmers and agrotextile kits would be disbursed to the trained farmers with 90% contribution by the Government and 10% contribution from farmers/state Government with upper limit of Central Govt. Contribution of Rs. 5 lakhs per farmer. With increase in usage of agrotextiles, it is expected that it would benefit both agriculturists as well as textile entrepreneurs in the country. The State-wise details is at **Annex-I**.

(ii) Scheme for Promoting Usage of Agrotextiles in India (excluding North Eastern States):- This scheme is broadly on similar pattern and with same objectives as that of Scheme on Agrotextiles for North Eastern Region. This has been introduced in the year 2015 for a period of two years (2015-16 and 2016-17) with a fund outlay of Rs. 5.00 crore. The State-wise details is at Annex-II.

(c) & (d): No, Madam. Both the above mentioned schemes are being implemented directly by M/o Textiles, Government of India. As such, no central assistance has been given under these schemes directly to any states including Maharashtra.

(b) Agrotextile kits: A total 531 Agrotextile kits have been approved for distribution in Manipur & Mizoram out of which 176 agrotextile kits are under distribution.

# (ii) Scheme for promoting usage of agrotextiles in India (excluding North Eastern States) :

- i. Two demonstration centres are being established in Amravati District of Maharashtra.
- ii. 40 farmers have also been identified from the Amravati District to whom Agrotextile kits would be distributed shortly.
- iii. Eight more proposals for establishment of demonstration centres have been approved and are at various stages of implementation. The state-wise details are given below:
