- (a): The details of the educational institutes under the Ministry and its organisations awarding degrees or diplomas to the students and students, course-wise are given in Annexure.
- (b) & (c): These educational institutions meet all the procedural and statutory requirements/ clearances including approvals from agencies concerned. National Institute of Fashion Technology (NIFT) is governed by the NIFT Act, 2006 under which the Institute grant degrees, diplomas, certificates and other academic distinctions. The courses offered by Sardar Vallabhbhai Patel International School of Textiles and Management (SVPISTM), Indian Institutes of Handloom Technology (IIHT) and Indian Institute of Carpet Technology (IICT) are approved by the All India Council for Technical Education (AICTE). However, AICTE approval for IIHT, Fulia is under process as the institute has started functioning from the current academic year. The courses under Central Silk Board (CSB) are meeting the procedural requirements of University Grants Commission (UGC).
