ANNEXURE-II REFERRED IN THE REPLY GIVEN IN PART (c) OF LOK SABHA UNSTARRED QUESTION NO. 3332 FOR ANSWER ON 18.12.2015

Requisition for recruitment of vacancies of SC/ST category are sent from time to time to various Central Recruiting agencies namely SSC / UPSC and Employment Exchanges. Defence Establishments have also been instructed to put up the backlog vacancies of SC / ST on their respective websites. They have also been advised to form a Committee of Officers to monitor the progress of backlog vacancies meant for SC / ST.

2. De-reservation of SC vacancies is being discouraged and concerned Defence Establishments are advised to avoid de-reservation of SC / ST vacancies. Further, they have been instructed to fill up the SC / ST vacancies in accordance with the guidelines / provisions of DoPT.
