(b) A Committee was constituted in August 2010 under the Chairmanship of Shri Mani Shankar Aiyar, Hon'ble Member of Parliament (Rajya Sabha) to review the functioning of all seven Zonal Cultural Centres (ZCCs).

(e) The details of the major activities of all the seven ZCCs during the last five years and the current year are enclosed at **Annexure-A**.

- Under Guru Shishya Parampara Scheme, 411 Gurus benefitted.
- Total 263 Artistes benefitted under Young Talent Scheme.
- Organized 2705 Shilpa Gram Festivals and other events apart from conducting 693 Plays, Theatre Shows etc.
- Organized 617 Lok Tarang Folk Dance Festival.
- Organized Opening Ceremony of Silver Jubilee Celebrations on 13th April, 2012.
