(a): The details of funds allocated and released under the Border Area Development Programme (BADP) during the last three years and the current year, state-wise are annexed. As per the Annual Action Plans furnished by the States implementing BADP, the works undertaken by the States are related to (i) Road infrastructure, (ii) Education, (iii) Health, (iv) Agriculture & allied sectors, (v) Social Sector, (vi) drinking water, (vii) electricity, (viii) skill development etc.

(b) and (c): Government is making efforts under BADP to develop all the border area of the country as per the requirements of the areas.
