4136: SHRI KODIKUNNIL SURESH:

Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) whether the Government is implementing the Skill Development Initiatives (SDI) programmes under the Modular Employable Schemes;
- (b) if so, the details of the schemes, financial and physical targets and achievements during each of the last three years and the current year, State-wise;
- (c) whether VTPs are registered under the SDI and if so, the details thereof, State-wise;
- (d) whether assessing bodies are affiliated with SDI and if so, the details thereof, State-wise; and
- (e) whether the Government has contemplated any action to stop the skill development initiative programme and if so, the reasons therefor?

ANSWER

**MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF
SKILL DEVELOPMENT AND ENTREPRENEURSHIP
(SHRI RAJIV PRATAP RUDY)**

- (a) Yes. Government has been implementing Skill Development Initiative (SDI) Scheme since May 2007 with an objective to provide training and employment to people to improve their employability. The implementation of the scheme is being done through Vocational Training Providers (VTPs) empanelled by State Governments and monitored through an online portal.
- (b) The Salient Features of the scheme are :
 - i. Training is imparted as per the need of the target group.
 - ii. Skills of the person acquired through Vocational Training Provider (VTP) are assessed by independent assessing body.
 - iii. Skills of an individual acquired informally are assessed.
 - iv. Training cost and Assessment fee are reimbursed to VTP and Assessing body respectively.
 - v. Successful persons are awarded certificate issued under the aegis of National Council for Vocational training (NCVT).
 - vi. Day boarding and transportation charges are allowed to person living in North Eastern States, LWE and hilly areas when they come out of these areas for training.
 - vii. Persons having age more than 14 years can undergo training.

The State/UT-wise details of the physical targets and achievements during last three years and the current year is at **Annex.I**.

The State/UT-wise details of the financial achievements during last three years and the current year is at **Annex.II**.

(c) Training under the SDI scheme is provided by various registered Vocational Training Providers (VTPs) under Central Government, State Governments, Public and Private sector industrial establishments. VTPs are registered through State/UT governments. The State-wise detail of the number of registered VTPs is at **Annex.III**.

(d) Under the scheme, Testing/ assessment of the competencies is done by empanelled assessing bodies. Total, 116 assessing bodies empanelled for conducting assessment. 64 more assessing bodies provisionally empanelled. The list of the 116 assessing bodies is at **Annex.IV**.

(e) The continuation of SDI scheme has been approved by the Cabinet Committee on Skill Development (CCSD) for XII five year Plan (2012-2017).
