INDIAN FISHERMEN IN FOREIGN JAILS

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) the total number of Indians including fishermen lodged in foreign jails at present, country-wise, particularly in Pakistan and other neighbouring countries;
- (b) whether attacks on Indian fishermen by Pakistan and Sri Lankan Navy is on the rise and if so, the details along with the number of fishermen and boats seized by these countries during the last one year;
- (c) the total number of Indians and boats released by Pakistan and Sri Lanka during the last one year; and
- (d) the steps taken to get all the prisoners including fishermen, soldiers, civilians, etc. and their boats released from these countries along with the intervention of International fora, if any, availed for the purpose?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS [GEN. (DR) V. K. SINGH (RETD)]

(a) As per information available with this Ministry, there are 240 prisoners in Pakistani jails who are believed to be Indians, out of which 192 are fishermen. In addition, 74 missing Indian defence personnel are also believed to be in Pakistan,

but this has not been acknowledged so far by Pakistan. 61 Indian prisoners are in Sri Lankan jails, out of which 33 are fishermen.

A detailed country-wise list showing the total number of Indian prisoners, including fishermen, in jails in foreign countries, is placed at Annexure.

(b) & (c) According to information available with this Ministry, 313 fishermen, believed to be Indian fishermen, were apprehended by Pakistan over the past one year. Out of these, 276 Indian fishermen have been released by Pakistan.

In Sri Lanka, in the past one year, 400 Indian fishermen were arrested. Due to the Government's steadfast efforts, 367 of these fishermen have been released and repatriated. In the same period, a total of 64 boats were detained, out of which 8 have already been released and 56 still remain in the custody of the Sri Lankan authorities.

(d) After confirmation of the Indian nationality of the person, our Missions make all possible efforts with the foreign Governments to provide necessary assistance to Indians imprisoned in jails, which include requesting local authorities for speedy trials, seeking remission of sentences, providing advice and guidance in legal and other matters, ensuring fair and humane treatment in foreign jails and repatriation to India of those who are released. In some countries, our Missions also request the local Government to grant amnesty to the arrested or convicted Indians. As per information available from the Ministry of Home Affairs, we have operational agreements with 35 countries for transfer of sentenced persons.

The Government attaches the highest priority to the safety, security and welfare of Indian fishermen. Our Missions and Posts regularly seek consular access to Indian fishermen detained in foreign countries, ensure their welfare and also pursue their early release and repatriation, along with their boats. Given the humanitarian and livelihood dimensions of this issue, the Government has put in place several bilateral mechanisms to ensure cooperation and understanding between India and the countries concerned, to promote the safety and security of Indian fishermen.

In case of Pakistan, we have a bilateral Agreement on Consular Access, signed in May 2008. The India-Pakistan Joint Judicial Committee, consisting of retired judges from both countries, visit jails in both countries, to review the situation of prisoners, including fishermen, on both sides.

In the case of Sri Lanka, our Mission works closely with the Sri Lankan Ministry of Defence, the Attorney General's Office and the law enforcement agencies concerned, to secure the release and repatriation of our fishermen. There is a Joint Working Group on Fisheries and a Joint Committee on Fisheries, which take up fishermen's issues for resolution on basis of the bilateral Understanding on Practical Arrangements of October 2008. In addition, talks are held from time to time between Fishermen's Associations in India and Sri Lanka.
