701.SHRI Y.V. SUBBA REDDY:

Will the Minister of LAW AND JUSTICE be pleased to state:

- (a) whether most of the Electronic Voting Machines (EVMs) have become outdated or likely to become outdated soon in the country;
- (b) if so, the details thereof;
- (c) whether the Election Commission has asked the Government to sanction money for new EVMs to meet the projected requirement for use in future; and
- (d) if so, the details thereof and the action taken by the Government thereon?

ANSWER

MINISTER OF LAW AND JUSTICE (SHRI D.V. SADANANDA GOWDA)

- (a) and (b): The Election Commission has stated that 9,30,430 Electronic Voting Machines (EVMs) would become outdated during the period 2015-16 to 2019-20.
- (c) to (d): A proposal for purchase of 13,95,648 Ballot Units (BUs) and 9,30,432 Control Units (CUs) at an estimated cost of Rs. 5511.48 crore during 2015-16, 2016-17, 2017-18 & 2018-19 has been received from the Election Commission. The proposal is under consideration of the Government.

(a) to (b): Yes, Madam. The ECI has already proposed to replace the pre-2006 EVMs in a phased manner as under which is under consideration of the Government:-

(c) to (d): The Election Commission has requested to sanction the amount for new EVMs to meet the projected expenditure for use in future.

The expenditure in procurement of upgraded post-2006 EVMs to phase out the pre-2006 EVMs purchased from 2000 to 2005, and also for staggered purchse of VVPAT units by the year 2018, based on tentative price of Rs. 7867/-, Rs. 9605/- and Rs. 20347/- per Ballot Unit (BU), Control Unit (CU) and VVPAT unit respectively, will be as under:-
