**PROJECTS UNDER PMGSY**

**842. SHRI TARIQ ANWAR:**

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether the Government has received any proposal under the Pradhan Mantri Gramin Sadak Yojana (PMGSY) scheme from the States of Bihar and Uttar Pradesh during the last two years and the current year;
- (b) the number of kilometers in bordering districts of Bihar likely to be covered under the PMGSY during the next two years; and
- (c) if so, the details thereof?

**ANSWER

(a): Since inception of the Pradhan Mantri Gram Sadak Yojana (PMGSY), the Ministry has so far cleared proposal to construct 50,035 Kms of roads amounting to Rs. 25,701 Crore to Bihar and 52,604 Kms of roads amounting to Rs. 14,592 Crore to Uttar Pradesh (upto 2<sup>nd</sup> December, 2015). The States have reported to have completed a road length of 34,653 kms of roads with an expenditure of Rs. 16,969 crore in Bihar and 44,679 kms of roads with an expenditure of Rs. 11,747 crore in Uttar Pradesh ( till October, 2015). The details of proposals sanctioned to these two States during the last two years and the current year is as under :
