(b) whether the Government has set any target/estimates for wheat procurement during 2016-17 marketing year, if so, the details thereof and the steps taken thereon;

(c) whether the Government has urged the States to open adequate number of procurement centres; and

(d) if so, the details thereof and response of the States thereto indicating the number of centres proposed to be opened, State and agency-wise?

(a): The statement showing production and procurement of wheat, rice and coarsegrain for the last two years is at Annexure-I.

(b): The Government of India has set a target of 305 Lakh Metric Tonnes for procurement of wheat for Rabi Marketing Season (RMS) 2016-17. The statewise details of the target set for procurement of wheat for RMS 2016-17 is at Annexure-II. Further, the Government has finalized the arrangements of procurement of wheat during RMS 2016-17 in a meeting of State Food Secretaries held on 15th February, 2016.

(c) & (d): Yes, Madam. The Government of India has urged the State Governments to open adequate number of procurement centres. The issue has been discussed in State Food Secretaries meeting held on 15.02.2016 and they have chalked out detailed action plan for the State for procurement of wheat during the ensuing wheat marketing season RMS 2016-17. The list of procurement centres to be opened for RMS 2016-17 is already mentioned Annexure II.
