Will the Minister of AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

- (a) whether the Government has formulated any policy for upgradation and renovation of AYUSH hospitals, medical institutes and dispensaries, if so, the salient features thereof;
- (b) the funds allocated for the purpose during the last three years and the current year, State/UT-wise;
- (c) whether the Government proposes to associate the Indian Council of Medical Research for realising full potential and developing herbal medicines through institutional programmes; and
- (d) if so, the details thereof along with the funds allocated for the purpose?

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO 202 FOR 11TH MARCH, 2016

- (a) Government of India evolved the National Policy on Indian Systems of Medicine & Homoeopathy-2002 for the development of various disciplines of Indian Systems of Medicine which inter-alia envisage the following:
- (i) To promote good health and expand the outreach of health care to our people, particularly those not provided health cover, through preventive, promotive, mitigating and curative intervention through Indian Systems of Medicine & Homoeopathy (ISM&H).
- (ii) To improve the quality of teachers and clinicians by revising curricula to contemporary relevance and researches by creating model institutions and Centres of Excellence and extending assistance for creating infrastructural facilities.
- (iii) To ensure affordable ISM&H services and drugs which are safe and efficacious.

Further, the Central Government launched National AYUSH Mission (NAM) on 29.09.2014 which envisages better access to AYUSH services, strengthening of AYUSH educational institutions, facilitate the enforcement of quality control of Ayurveda, Siddha and Unani & Homoeopathy (ASU &H) drugs and sustainable availability of ASU & H raw-materials in the States/UTs during 12th Plan. The NAM *inter-alia* makes provision for upgradation and renovation of AYUSH hospitals, medical institutes and dispensaries. The details are furnished at **ANNEXURE-I.**

(b) The funds allocated for the upgradation and renovation of AYUSH hospitals, AYUSH medical institutes and AYUSH dispensaries during the last three years and the current year, State/UT-wise is furnished at **ANNEXURE-II.**

(c) and (d). Central Council for Research in Ayurvedic Sciences (CCRAS) and Central Council for Research in Unani Medicine (CCRUM), both autonomous bodies under the Ministry of AYUSH have signed Memorandum of Understanding (MOU) with Indian Council of Medical Research (ICMR) for undertaking collaborative research projects under their respective schemes and programmes. CCRAS have taken up collaborative projects under Reproductive and Child Health (RCH) Programme, Golden Triangle Partnership (GTP) Scheme, Extra Mural Research (EMR) Scheme of Ministry of AYUSH. CCRUM is collaborating in the field of Tuberculosis with National Institute for Research in Tuberculosis (NIRT), Chennai, which is one of the premier institutes of ICMR.

To converge the research approach of AYUSH systems with the modern system of medicine, the Ministry of AYUSH and Indian Council of Medical Research (ICMR) have together decided to have molecular based studies on specific leads from AYUSH.

No separate funds are allocated for this purpose.

ANNEXURE-I

A. <u>Upgradation of exclusive/standalone Government AYUSH hospitals</u>

Financial assistance is provided for upgradation and improvement of existing AYUSH hospitals under the State Government/Zila Parishads.

i. One Time grant:

Up to Rs 75.00 lakhs for undertaking construction, renovation of existing premises; furniture, fixtures, equipments, etc. subject to the condition that expenditure on addition/ alteration of existing premises will not exceed 75 per cent of the total amount.

ii. Recurring Grant (per annum):

Rs. 0.70 Lakhs per annum as lump sum contingency fund

Rs. 4.50 Lakhs per annum for procurement of drugs, medicines, diet and other consumables.

- **iii.** State may engage the following personnel as per their need and salary may be decided as per the local criteria:
- a. AYUSH Specialists having PG qualifications- 2 (two)
- b. AYUSH Medical Officer-1 (one)
- c. AYUSH Pharmacists- 2 (two)
- d. Para Medical Staff- Masseurs- 2 (two),
- e. Kshar Sutra Attendant-1/ Stri Roga Attendant- 1/Ilaj-bid-Tadbir attendant/Thokkanam attendant-1/Homoeopathy Attendant-1/Yoga Attendant-1
- **iv.** Subject to the conditions that the additional requirement of personnel shall be assessed and projected keeping in view the personnel already in position. All the appointments will be contractual and the Central Government's liability will be limited to the extent of Central Share admissible for the cost on salary for the mission period.

B. Upgradation of Government/Panchayat/Government aided AYUSH Dispensaries

i. One Time grant

Up to Rs 20.00 lakhs for undertaking construction, renovation of existing premises; furniture, fixtures, equipments, etc. subject to the condition that expenditure on addition/ alteration of existing premises will not exceed 75 per cent of the total amount.

ii. Recurring Grant (per annum)

Rs. 0.10 Lakhs per annum as lump sum contingency fund

C. Infrastructural development of AYUSH Under-Graduate Institutions

State Govt./Govt.-aided institutions duly *permitted* by the Central Government for last five years under Indian Medicine Central Council (IMCC) Act 1970 and Homoeopathy Central Council Act, 1973 are eligible. Assistance will be given on a Detailed Project Report for upgradation of the UG Institution.

Pattern of assistance:

- i) Construction of OPD/IPD/Teaching Departments/Library/ Laboratories/Girls' Hostel/Boys' Hostel, etc. Rs. 210.00 Lakhs
- ii) Equipment, Furniture, and Library books Rs. 90.00 Lakhs

D. <u>Infrastructural development of AYUSH Post-Graduate Institutions/add on PG Pharmacy/Para-Medical Courses</u>

State Govt./Govt.-aided institutions duly *permitted* by the Central Government for last five years under Indian Medicine Central Council (IMCC) Act 1970 and Homoeopathy Central Council Act, 1973 are eligible. Assistance will be given on a

Detailed Project Report for upgradation of the PG institutions or for add on AYUSH Pharmacy/Para-Medical Courses.

Pattern of assistance:

(i) Construction of OPD/IPD/Teaching Departments/Library/Laboratories/Girls' Hostel/Boys' Hostel, etc.

Rs. 280.00 Lakhs

(ii) Equipment, Furniture, Library books & Payment of stipend to students for new PGs

Rs. 120.00 Lakhs
