(a) The total budgetary allocation for defence sector excluding defence pension and Ministry of Defence (Civil) utilization thereof during each of the last three years and the current year is as follows:-

(b) The expenditure on Defence Capital acquisition in respect of orders placed on Indian Vendors and Foreign Vendors during the last three financial years is as under:

The expenditure on Defence Capital acquisition in respect of orders placed on Foreign Vendors and Indian Vendors during 2015-16 is not yet compiled. Such compilation is done after conclusion of the financial year.

(c) Capital procurements for the defence forces flow from the defence procurement planning process comprising 15 year Long Term Integrated Perspective Plan (LTIPP), five year Service Capital Acquisition Plan (SCAP)

and Annual Acquisition Plan (AAP). The LTIPP 2012 to 2027 is currently in vogue. The schemes included in the AAP are progressed as per Defence Procurement Procedure (DPP). The DPP contains timelines for completion of various stages of capital procurement process.

(d) LTIPP covers the technology domains of aeronautics, missiles, armaments, combat vehicles and engineering etc. and priority is given to support ongoing commitments in projects. However, details of allocation to DRDO under revenue and capital heads are as follows:-
