**(a): Ministry of Tourism has launched the Swadesh Darshan scheme in the year 2014-15 with a vision to develop theme based tourist circuits on the principles of high tourist value, competitiveness and sustainability in an integrated manner by synergizing efforts to focus on needs and concerns of all stakeholders to enrich tourist experience and enhance employment opportunities. The Ministry has identified Eco-Tourism Circuit as one of the thirteen thematic circuits for development under this scheme.**

**(b) and (c): The details domestic and foreign tourist visits in Gujarat State during the last two years are as under:**
