(a) to (d) Ministry of Skill Development and Entrepreneurship (MSDE) is working meticulously with All India Council for Technical Education (AICTE) to utilize the existing spare infrastructure/ capacities of AICTE approved engineering colleges/polytechnics for conducting National Skill Qualification Framework (NSQF) compliant National Council for Vocational Training (NCVT) courses/short term skill courses under Pradhan Mantri Kaushal Vikas Yojana (PMKVY). Already closed Engineering colleges/Polytechnics may apply directly for affiliation to run above courses.

As per the information provided by AICTE, 31 institutions have been closed and 84 institutions have applied for closure across the country. State wise details are **Annexed**.

A committee has been constituted by AICTE for feasibility study for utilization of the surplus infrastructure of engineering colleges / polytechnics for running NSQF compliant NCVT courses.
