Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of programmes/schemes introduced by the Union Government for skill development and the number of beneficiaries having availed the benefits under these programmes during the last two financial years and the current year, State-wise;
- (b) whether the proposals of various State Governments including Gujarat for skill development are under consideration of the Government;
- (c) if so, the time by which a decision is likely to be taken on these proposals;
- (d) whether the Government proposes to set up training centres at district levels under the schemes; and
- (e) if so, the details thereof?

STATEMENT TO BE LAID ON THE TABLE OF THE HOUSE IN RESPECT OF PART (a) TO (e) OF LOK SABHA STARRED QUESTION NO. 3 ADMITTED FOR REPLY ON 24.02.2016 REGARDING "PROGRAMME FOR SKILL DEVELOPMENT"

(a) to (e) There are over 40 skill development schemes across various sectors implemented by over 18 Central Ministries/Departments to promote skilling of all people including youth, in the Country. Funds under these schemes are provided by the concerned Ministries/Departments to the implementing agencies including States in accordance with the guidelines issued for the schemes. The list of schemes is attached at **Annexure**.

Details of people trained under various skill development schemes/programmes of over 18 Central Ministries/Departments for the year 2012-13 to 2015-16 (upto December, 2015) are as under:-

Further, Government has launched the flagship scheme, 'Pradhan Mantri Kaushal Vikas Yojana (PMKVY)' on 15th July, 2015 to enable and mobilize a large number of youth to take up outcome based skill training and earn their livelihood. It is a skill certification and reward scheme where in trainees after their successful assessment and certification, get monetary reward through direct bank transfer to their account. The scheme has the target to benefit 24 lakh persons with training of 14 lakh fresh entrants and certification of 10 lakh persons under Recognition of Prior Learning (RPL). The National Skill Development Corporation (NSDC), the Public Private Partnership (PPP) entity is the implementing agency for PMKVY. As on 22nd February, 2016, 12.50 lakh candidates have been enrolled in 9,314 training centres spread across the Country with coverage of 29 States and 6 Union Territories (UTs).

Further, Government is constantly engaged with State Governments in its endeavor to scale up skill development in the country. There are following schemes under implementation through Ministry of Skill Development and Entrepreneurship for skill development in collaboration with the State Governments:-

- (i) Upgradation of Government Industrial Training Institutes (ITIs):- The scheme has a provision of Rs. 300 crore for upgradation of 29 ITIs into model ITIs with the funding pattern between Centre and State as 70:30 (90:10 for North Eastern States). So far, 18 ITIs have been identified including the ITI, Dashrath (Gujarat) to be upgraded into model ITIs.
- (ii) Upgradation of 400 Government ITIs:- Under the World Bank assisted Vocational Training Improvement Project (VTIP), 400 Government ITIs existing in 29 States and 5 Union Territories are to be upgraded.
- (iii) Enhancing Skill Development Infrastructure in North Eastern States and Sikkim:- The scheme aims to upgrade 20 ITIs by introducing 3 new trades per ITIs and supplementing infrastructure deficiencies in 28 ITIs by constructing new hostel, boundary wall and supplementing old and obsolete tools and equipments. The scheme has a new component for establishment of 22 new ITIs in 8 North Eastern States.
- (iv) Skill Development in 34 districts affected by Left Wing Extremism (LWE):- Under the scheme, infrastructure is to be created for 34 ITIs (one ITI per district) and 68 Skill Development Centres (SDCs) (two SDCs per district) in the areas affected by LWE.

Furthermore, with the objective to provide skilling opportunity to the people across the Country through high quality training centres, the Government has entrusted NSDC to promote a Model Skill Centre (MSC) in more than 500 districts across the Country. Expression of Interest (Eoi) for setting up of these MSCs) was invited against which more than 1800 companies have applied.
