Will the Minister of DRINKING WATER AND SANITATION be pleased to state:

(a) the details of foreign aided drinking water and sanitation projects approved along with the name of the funding agencies and the status of each of these projects, State / UT-wise;

(b) the details of the funds received in this regard, project-wise and State / UT-wise; and

(c) the time by which these projects are likely to be completed and the details of monitoring mechanism put in place for effective implementation of these projects?

ANSWER MINISTER OF STATE FOR DRINKING WATER AND SANITATION (SHRI RAM KRIPAL YADAV)

(a) to (c) Rural Drinking Water Supply is a State subject. This Ministry supplements the efforts in form of technical and financial assistance to the States in this respect. As financial assistance to uplift the Piped Water Supply coverage, this Ministry has arranged financial assistance from World Bank for four States namely Assam, Bihar, Jharkhand and Uttar Pradesh. The details in this respect are at Annexure-I. Many other states are also executing rural water supply schemes with foreign aid taken directly by them on the recommendation of this Ministry and Ministry of Finance. Disbursal and Re-Payment of the loan are not through this Ministry. The details of such projects are at Annexure-II.

At the national level, as on date, there is no approved foreign aided Project for Rural Sanitation.
